## CONTRACT AGREEMENT

THIS CONTRACT made on June 11, 2014 by and between:

Mindoro, represented by its College President, DR. JESSE T. ZAMORA, hereinafter referred to as the PROCURING ENTITY;

MAXCOR INTER-VENTURES CO, duly organized and existing under the laws of the Republic of the Philippines with office address at 105 Engineering Road, Araneta University Village, Potrero, Malabon City, represented by its Business Development Consultant, ALLAN DELA CRUZ MASANQUE hereinafter referred to as the SUPPLIER;

- witnesseth -

WHEREAS, the PROCURING ENTITY is desirous that certain goods and services should be executed via-Contract to do the **Supply and Delivery of IT Equipment for Computer Laboratories in MinSCAT- Main Campus**, MinSCAT - Main Campus, Alcate, Victoria and has accepted a bid by the supplier for the execution and completion of such goods and services.

Now this Contract witnessed as follows:

1. In this Agreement words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall deemed to form and be read and construed as part of this Agreement, viz:

  - b. the Schedule of Requirements
  - c. the Technical Specifications
  - d. the General Conditions of Contract
  - e. the Special Conditions of Contract
  - f. the Entity's Notification of Award

In consideration of the payment to be made by the PROCURING ENTITY to the SUPPLIER hereinafter mentioned, the SUPPLIER hereby covenants with the PROCURING ENTITY, to provide the goods and services and to remedy defects therein in conformity with the provisions of this Contract Agreement. The Contract completion time is TEN (10 c.d.) calendar days from the date Notice to Proceed is received by the SUPPLIER.

The PROCURING ENTITY hereby covenant to pay to the SUPPLIER in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price in the amount of to **Five Hundred Sixty Six Thousand Three Hundred Twenty Two pesos** or such other sum as may become payable under the provisions of the Contract at the time and in the manner prescribed by the contract.

5. The provision of RA 9184 and its implementing rules and regulations and amendments shall apply to matters not therein above provided and as adopted by the BAC.
